All interested trade partners must preliminarily prequalify to be eligible to propose. Trade partners who have previous prequalified via Trade Tapp with Mortenson or their affiliates are required to complete this project-specific prequalification process. Visit www.progressivefieldreno.com to start the prequalification process. Prequalification closes at 11:59 PM Eastern Time on June 20, 2023. Firms who do not complete this process will not be eligible to propose for PP#2 or PP#3.

Plans and specifications will be available to prequalified trader partners via Building Connected.

Submit (1) electronic proposal via building connected no later than 2:00 PM Eastern Time on July 21, 2023.

Proposals shall be valid for 120 days.

It is the policy of the Cleveland Guardians and the Mortenson/Independence/AKA to ensure that diverse firms have an equal opportunity to receive information and participate in the Progressive Field Renovation Project.
