

Q. Once the prime contractor downloads the docs will the primes also be able to download the subcontractor information that expressed interest?


A. Primes will be able to view the subs, but there is not download option at this time

- A. Yes, through the view function of the Public Document Takers, the Prime's Contact Information will be accessible


